Discontinuation Bonus Option/Plan under schemes of Pramerica Mutual Fund:

NOTICE is hereby given that **Bonus Units** Option/Plan (hereinafter referred to as "Bonus Option") under the following schemes of Pramerica Mutual Fund ("the Schemes") shall be discontinued w.e.f. June 15, 2015.

- Pramerica Liquid Fund;
- Pramerica Ultra Short Term Bond Fund;
- Pramerica Dynamic Bond Fund;
- Pramerica Short Term Income Fund;
- Pramerica Income Fund.
- Pramerica Short Term Floating Rate Fund;
- Pramerica Dynamic Monthly Income Fund;
- Pramerica Credit Opportunities Fund;
- Pramerica Treasury Advantage Fund;

Accordingly, the Schemes would have only Dividend and Growth Option thereafter, with <Growth> Option as the default option.

Consequently, no fresh subscriptions would be accepted under the Bonus Option of the Schemes – whether by way of fresh subscription or additional purchase or under Systematic Investment Plan (SIP).

The outstanding units in respect of the existing unit holders under the Bonus Option/Plan shall be continued, without allowing any fresh subscription from the unitholder, till all units under the Bonus Option/Plan of the scheme have been redeemed and subsequently, the Bonus Option/Plan shall be closed.

The aforesaid changes will be applicable with effect from June 15, 2015. Accordingly, SIP transactions under the Bonus Option of the Schemes would also be discontinued from the same date.

All the other provisions of the SID/KIM, except as specifically modified herein above, remain unchanged.

This Notice-cum-Addendum forms an integral part of the SID/KIM of the above mentioned Schemes, as amended from time to time.
